### APPLICATION FOR INDIVIDUAL MEMBERSHIP

The Council of Centers on Jewish-Christian Relations is an association of centers and institutes in the United States and Canada devoted to enhancing mutual understanding between Jews and Christians. It is dedicated to research, publication, educational programming, and interreligious dialogue that respect the religious integrity and self-understanding of the various strands of the Jewish and Christian traditions. Our members are committed to interreligious dialogue that does not seek to persuade or convert the other, but rather seeks to be enriched by each other's religious lives and traditions.

Although primarily composed of organizational members, in 2006 the Council voted to establish a new category of membership for individuals professionally engaged in Jewish-Christian relations. These could include (but are not restricted to): diocesan ecumenical officers, staff at agencies involved in interfaith work, educators, dialogue organizers, etc. In 2011 this category was expanded to include students training for work in the field.

Such individuals are being invited to join the Council in order to network with others in the field, to share resources and concerns, and to discuss relevant issues. Individual members will be invited to annual CCJR meetings and to observe the annual business meeting without a vote, which is restricted to the organizational members that form the principal constituency of the CCJR. Individual members will also be subscribed to the CCJR listserv so as to be kept informed of current news and events in Christian-Jewish relations.

The annual membership fee is \$30. This fee is waived for students.

The CCJR Board will review applications for individual membership and the Secretary will notify the applicant of the decision.
